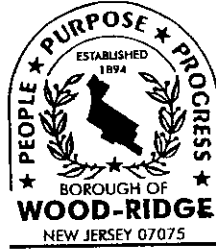

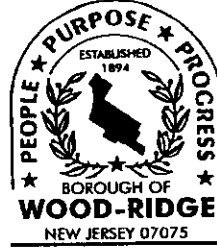

Reorganization Meeting – January 1, 2011**

**Mayor Paul A. Sarlo's Address**

Good Afternoon . . . Happy New Year to all of you. A year I hope that is healthy and prosperous.

Since I was first elected to the Borough Council in 1995 this is my 16<sup>th</sup> reorganization meeting that I have participated in and the 12<sup>th</sup> that I will preside over as Mayor.

This will be the first reorganization meeting that my Dad has not attended so like so many other important events and holidays in the next 8 months there will be many more firsts for me with him not here. If he was hear he would complain to me afterwards that too many people don't speak into the microphone and it is difficult to hear. Hopefully he heard us well this afternoon and I know he is with me every step of the way.

Today is another special reorganization because we sworn in another new member to the Council, last year it was Councilman Marino, and this year Councilman Joseph DiMarco. These are special moments because we welcome a new public servant into our Borough family.

Let me take a moment to congratulate our two Council people who have just been sworn in:

. . . Catherine Cassidy, a hometown product, begins her 5<sup>th</sup> term on the Council and was convincingly re-elected in a tough year being on a Democratic line because of her tenacity and advocacy for senior citizens, historical society, library, and some of our most

vulnerable citizens. The team effort that was put forward to get Cathy re-elected this year clearly demonstrates how and important member she is of our team.

.... to Joseph DiMarco, both Councilman Marino and I first met Joe about 6 years ago when our sons became active in organized sports. I quickly realized that Joe's commitment to his family, our Borough's children as well as appreciation of a homeowner's investment in a community combined with his small business acumen would provide the background to make him a great Councilman some day. So that day is here and I want to thank him for accepting our offer and the challenge to serve the public.

His commitment to our children and to a town that he has invested in and chose to raise his family will make him an outstanding Councilman and Public Servant.

Again to the balance of the members of the Council, I think I say it every year but as a Senator I have the opportunity to travel around the state and meet with various local elected officials, I must reiterate that we have one of the finest governing bodies in the state, all who commit a lot of time, energy, and passion to our community.

To our Borough Officials, Department Heads, and volunteers who make my job as CEO of the town a pleasure. They always there to keep our residents safe, respond to their needs, and provide so many services and activities.

To our professionals not only are they the finest around, but their long terms of service to our community make them part of our extended Borough family, especially my friend and counselor Paul Barbire.

Let me take a moment to recap 2010:

The Borough of Wood-Ridge experienced another year of strong financial performance despite severe cuts in state aid because of our conservative fiscal management and aggressive cost cutting.

The 2010 municipal budget only increased 2.3% and included \$500k in cuts which included seven employee reductions. We continued to save money because our dedicated employees worked with us to restructure health plans and contribute more to the cost of those plans.

The major hurdle that we had to overcome was the \$1 million cut in state aid to our school and our municipality. A dollar amount of that size could have been devastating to our budget and the services that we provide hadn't we not been prepared to deal with it. Had we received the same amount of state aid from 2009 there would have been no property tax increase.

In 2010 we continued to improve our balance sheet by increasing cash flow for the 4<sup>th</sup> consecutive year, avoided the need for the 3rd straight year to not employ any short term borrowing., and ending the year with a surplus for the second straight year.

Our efforts were recognized by Standard & Poors, the premier credit rating agency, which increased the Borough's credit rating 3 levels to AA.

Although we were in a tough economic climate, we did not waiver on our commitment to investing in our infrastructure by kicking the can down the road. We took advantage of low interest rates in the municipal market, an aggressive and competitive construction industry, and our low debt ratio to make some very modest capital improvements:

- Completed our road reconstruction and resurfacing program for the west side of town.
- With open space grants we refurbished and upgraded Veterans Park and the grounds at the historic Bianchi House.
- With historic preservation grant money we put on a new roof at the Bianchi House and refurbished the roof eaves back to their historic origin.

- New lease with the WR Little League
- Wesmont Station
- Shared Services Committee
- Purchase of Assumption School
- WR Mayor's 5K Race
- Bianchi House – Halloween Display
- Approval of a new bank and office at the corner of WR and Valley Blvd.

2011

- Paving of the west side of the town (a third of all roadways when we are done)
- Continued shared services with the Board of Education
- Renovations to the Assumption School
- Wesmont Station start the ball fields

On a personal note, I would like to thank the people of Woo-Ridge for their continued support and for allowing me to serve them in two capacities. I am truly honored for their annual confidence in me.

To my wife Connie and sons Anthony and Michael their love and support allows me to serve the public. I know it is not easy on them, so I thank you and I love you guys.
