DISCUSSION:

Wood-Ridge Board of Education opened up their meeting.

Board of Education President Albie Nieves did their role call; all members were present.

Special Joint Meeting of Mayor and Council and Wood-Ridge Board of Education regarding matters related to the Wesmont Station Redevelopment Project and the Wood-Ridge Intermediate School

Mayor Sarlo introduces our architects Mr. Joe DiCara and Mr. Alan Barnett.

A lengthy discussion ensued. School renovation should be finished by July 2013. They spoke about staffing, technology; computer lab, security system, budget needs and about the Special Education students coming back to the Wood-Ridge district.

The lease between the Borough and the Board of Education; a draft should be finalized by February. The BOE office will belong to the Borough of Wood-Ridge. Shared Services between the Borough and BOE was talked about. A budget of \$750,000 was discussed.

The Board of Education adjourned their meeting at 8:25PM.

HEARING OF CITIZENS:

Mrs. Barbara Fischkelta - 309 Innes Rd. - she asked about the bell schedule. Her concern was with all the schools being dismissed at the same time. She asked if a traffic study has been done. The Mayor advised Assumption School will have a drop off zone but the bell schedule is a BOE issue.

Mrs. Cathy Gonzalez - 220 Wood-Ridge St. - her concern was the lack of a crossing guard on Ryerson Ave. & Hackensack St; 2 children were hit by a car. Borough Administrator did not believe that 2 children were hit by a car because he gets all reports of pedestrian accidents but he would ask Police Chief to confirm. Mayor Sarlo advised that Ryerson Ave. & Hackensack St. are not crosswalks. The children should walk to Marlboro Rd. and cross by the Crossing Guard.


Mr. Ron Phillips - 55 Madison St. - he questioned the \$750,000 Capital Budget. Borough Administrator advised it will be bonded, that it will have a 10-15 year life span. It was explained in detail to Mr. Phillips.
