Mayor announced that Council looking in to setting a date for a community town hall meeting sometime in January to update residents on any developments at Wesmont Station. Mayor stated that the revaluation letters have been completed and sent to residents. He asked that if you not understand it, please call as indicated in the letter for clarification. Mayor explained that the State mandates all municipalities to perform this revaluation and why we must adhere to the guidelines set forth by the State.

FIRST HEARING OF CITIZENS:

Cheri Ottavare of 255 Innes Road asked what was going to happen to the dead end of Innes Road. Administrator Eilert explained the work currently being done on Innes Road was by PSEG and that trees were being removed in anticipation of new utility poles being installed. Mr. Eilert stated that there are no intentions of Innes Road being opened permanently and will remain a dead end street with emergency access only. Beth Boseski of 251 Innes Road asked why trees were not taken down on the Hasbrouck Heights side of the road. Administrator Eilert explained that this was a project by PSEG and unaware of why, but would be happy to find out for them.


