Police - On October 7th, Wood-Ridge residents spent time in the morning at "Coffee with a Cop" in Wesmont's Dunkin Donuts conversing with Chief Korin, and other Wood-Ridge police officers. Thank you to Dunkin Donuts who donated the coffee and donuts. On October 9th several Wood-Ridge Police Officers, including Chief Korin participated in the Special Olympics Torch Run. On October 24th the Wood-Ridge Police Department held "Operation Take Back Prescription Drug" program and collected over 30 pounds of prescription drugs for a successful collection. On October 30th & October 31st, Mischief Night and Halloween, our Police Officers, along with our Auxiliary Officers patrolled the town to make sure all residents were safe.

Recreation- These are the Recreation Commission Meeting minutes for the Recreation Commission Meeting of October 14, 2020. It was reported that AED/CPR Classes have resumed (11/17 & 12/1), Tuesdays at 7 p.m. at the Fire House. Fee is still \$50 for the two-year Red Cross Heart Saver Certification. Administrator Eilert stated the year end close out process has begun. This year, is, of course, a little unique because of the pandemic. We have a significant amount of monies that are being reimbursed to us by the CARES Act. He commended Borough Clerk Gina Affuso who has been his right hand on this. It is a very tedious software package that requires each item to be entered individually along with proof of expenditure for each item submitted. Due to her efforts, we are recovering close to \$200,000.00 in overtime costs and expenses for PPE and other necessities due to the pandemic. That said, we do not know if will receive the reimbursement money in this year or next, so that would determine whether we need to do budget transfers or declare a budget emergency in order to cover those costs until the funds are received.

Mayor Sarlo stated he recently walked the new walking path that is not open to the public yet. He expressed how nice it is and feels everyone in the community will enjoy it when it opens in the spring.
