Council President Marino opened the hearing of the 2021 Municipal Budget.

Administrator Eilert stated the borough is \$438,000 under our appropriation budget cap. Theoretically, this means we can spend \$438,000 more than what we anticipated. We are also \$838,000 under the tax levy CAP which means we can raise that additional amount in tax revenue and still be under the state cap amount. As introduced, the municipal tax rate is essentially flat.

With no citizens wishing to be heard, the hearing of the 2021 Municipal Budget was closed.

Councilperson Altamura:

Police-Each member of the police department completed their annual training on HAZMAT (Hazardous Materials training for first responders). At the monthly PBA meeting two new members were sworn in to Local PBA 313. (Ptl. Robert Francis and Ptl. Michael Donato). Members of the WRPD, along with family and friends attended the annual BLUE MASS at Assumption Church. Sgt. Robert Jones began a two- week training course where he is currently a police motor officer instructor. Sgt. Jones is in his 10th year instructing police officers to become motorcycle officers. Sgt. Robert Jones held a training course on C.P.R. This training was offered to a group of Wood-Ridge athletic coaches and volunteers. Members were given the Attorney General's Directive on the use of Body Worn Cameras with every officer receiving initial training on the device to be followed by in-service refresher training.

Recreation- The meeting of the Recreation Commission was held on Wednesday, May 12, 2021. Fall Registrations are now being accepted for Cheering, Football and Soccer. Summer Recreation will be held from July 1st through July 30th for children entering 1st through 8th grade in September. A Blue Devils Basketball Camp will be held from June 21st through June 24th – Children entering grades 2nd – 9th in September will be eligible. The following youth summer camps will also be offered: MVP Baseball /Softball Camp, July 5th – 8th and July 19th – July 22nd – Children who completed grades K-8th (ages 5-14); Blue Devils Football Youth Sports Camp, June 28th-June 30th – Children entering grades 2nd- 8th in September; Primavera Soccer Clinic, August 2nd – August 4th – Children ages 5-15; Sunday Morning Yoga will run throughout the Summer (Anna will be the instructor). The Borough of Wood-Ridge would like to thank Commissioner Loriann Iacovino for providing a Covid-19 vaccine program for ages 12 and over on May 22nd. hosted by Holy Name Hospital.

Keep Wood-Ridge Beautiful- Project "Keep Wood-Ridge Beautiful" celebrated its twenty first year on Sunday, June 6th. Over 250 volunteers participated with one of the largest groups in its history. It was held outdoors from 11:30AM- 3PM. The purpose of this event is to raise awareness of our environment and the impact of litter. Hackensack Street and Valley Boulevard were cleaned, while flowers were freshly planted at the Library, Civic Center, Senior Center, Veterans Park on Valley Boulevard and C.E. Doyle School. A shredding event was also held from 9 a.m. to 1 p.m. in front of the Civic Center sponsored by the Bergen County Board of Health & BCUA. This year's 2021 tee shirt art design contest was offered to students in grades 7-8 with the winner, Ms. Addison Passarella receiving a check for \$50 at the days event, compliments of the Mayor and Council with her artwork design and name prominently displayed on the front of each tee shirt with last year's 2020 winner, Ms. Olivia Sancillio having her artwork displayed on the back of the Tee shirt. A special Thank you to Tullo Ice of Hasbrouck Heights for donating ice and the Bergen County Dept. of Health for the use of their cleaning utensils. It was gratifying to see the shared efforts of many organizations in town including the Girl Scouts, Boy Scouts, Knights of Columbus, Transformation Life Church, WRHS students, Police Dept., Auxiliary, EMS department, Fire Dept. DPW along with individual families all working together with enthusiasm and cooperation for the betterment of Wood-Ridge. Wood-Ridge is a special place to live and it was certainly evident that friends and neighbors take pride in our community. I would like to encourage all residents and business owners to do their part to "Keep Wood-Ridge Beautiful" all year round by picking up litter and recycling. Set an example for all to follow! A special thank you to Council President Ed Marino, my co-chairperson for spending the entire day with me from setting up the shredder and concluding with picking up garbage bags along the cleaning route!

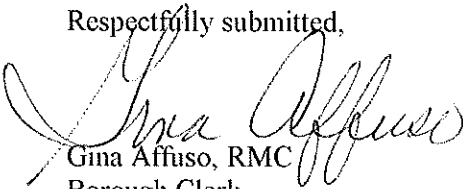
