Discussion: Administrator Eilert explained that Ordinances 2022-9 through 2022-12 are amending the language to allow for shared services contracts. Ordinance 2022-13 related to the developer dedicating these 2 streets to the borough. Bond ordinance 2022-14 includes repairs for roads and storm and sanitary sewers as well as the sidewalk and tree replacement program. Bond ordinance 2022-15 encompasses some major projects and some smaller projects. The main projects include renovating the High School Auditorium, building a new salt shed at DPW, renovating the fire house, building the playground and dog run and installing security cameras at the WR Athletic Complex, and beautifying Triangle Park at 4th Street with a new Gazebo to replace the one destroyed by a car accident. Smaller projects include a new boiler at Borough Hall, upgrades to the Donna Ricker Field Kitchen, painting the Bianchi House, and new Christmas decorations for Valley Boulevard and Borough buildings.
