REMARKS & PRESENTATIONS:

Councilwoman Cassidy:

Happy New Year. Hopefully 23 is far superior to the last three plus. . .

First, congratulations to Michele and Mike. Best wishes always. Even though I had about 9 months to write something I figured I wouldn't be able to get through it so I didn't write anything until last night.

Thinking about all of this, my first meeting went to midnight and I thought, oh my god, what did I get involved with - I go to bed at 9. Thankfully, it was agreed to always end by 11. The only long meeting after that was when we signed the developer's agreement for Wesmont and that went to about 3 am.

I have served in four different decades (much like Nolan Ryan pitching — my Mets reference for the Mayor) starting when I was 28. I worked with 5 police chiefs, 13 fire chiefs, 3 administrators, 2 clerks, and I think, 5 tax collectors. I am the last councilperson who served with a different mayor and maybe it was time to turn the page. I am so proud of the accomplishments of the last 24 years and can't wait to see what the future holds for Wood-Ridge. It has been a profound honor to serve and I can't thank the residents enough for keeping me in this position for as long as they have. I would like to thank my Borough family all the employees and staff and the Mayor, council and their families for their friendship and camaraderie these many years. But most importantly I want to thank my family for all their support during 8 campaign seasons and everything else for the last 24 years while I have been up here.

Councilman DiMarco:

Happy New Year everyone. Congratulations to Mike and Michelle. You are good people with big hearts and will do a great job for Wood-Ridge. Over 12 years ago when I was approached to be a councilperson, I had no interest in it whatsoever. However, I can honestly say that it has probably been the second-best decision of my life. Thank you, Cathy, for always pushing me to get out there and walk during campaigning and I appreciate you always being there for me.
