Police- The L.E.A.D. program continues at the Wood-Ridge Intermediate school. Officers are visiting the classrooms of the 6th grade to teach the students about character building and why its important to have high self-esteem. The officers talk about risky behavior and the consequences of their actions. The program is always well received by the students, parents and school staff. On March 24, 2023, Daisy Troop 584 visited the Wood-Ridge Police Headquarters to fulfill the requirements for a petal patch on their vest as part of the community involvement. Detective Marchitelli and Officer Cangialosi hosted the visit that lasted approximately one hour. In attendance were two Daisy leaders and approximately 11 Daisies. The Wood-Ridge Police Department is preparing for their biannual firearms training at the Wood-Ridge Police Firearms Training facility. This is a two-week endeavor that will fulfill the training required by the New Jersey Attorney General Guidelines. In attendance was Chief O'Donnell, Captain Biamonte, Captain Battaglia and Detective Marchitelli. The department representatives were well received by the student body.

WHEREAS, the Borough of Wood-Ridge, in the County of Bergen, New Jersey (the "Borough") from time to time issues bonds, notes and other obligations, the interest on which is excluded from gross income for Federal income tax purposes, and desires to take such action as may be necessary or advisable to establish and maintain such exclusion; and

WHEREAS, the Internal Revenue Code of 1986, as amended (the "Code"), contains provisions with respect to the exclusion from gross income for Federal income tax purposes of interest on obligations, including provisions, among others, which require issuers of tax-exempt obligations, such as the Borough, to account for and rebate certain arbitrage earnings to the United States Treasury and to take other action to establish and maintain such Federal tax exclusion; and

WHEREAS, the Borough intends to issue a \$6,651,000 Bond Anticipation Note, dated April 6, 2023 and payable April 20, 2023 (the "Note"); and

WHEREAS, the Borough desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Wood-Ridge, in the County of Bergen, New Jersey, as follows:

SECTION 1. The Borough Council hereby covenants on behalf of the Borough, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law and necessary to assure that interest paid on bonds, notes or other obligations of the Borough (including the Note) be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.

SECTION 2. The Mayor, Borough Clerk, Chief Financial Officer and the other officials of the Borough are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.

SECTION 3. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

SECTION 4. It is hereby determined and stated that (1) said Note is not a "private activity bond" as defined in the Code and (2) the Borough and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2023.

SECTION 5. It is further determined and stated that the Borough has, as of the date hereof, issued the following tax-exempt obligations (other than the Note) during the calendar year 2023:

SECTION 6. The Borough will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Borough does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

SECTION 7. The issuing officers of the Borough are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2023 dated as of the date of delivery of the Note.

SECTION 8. This resolution shall take effect immediately upon its adoption.

TRUST FUND APPLICATION MUNICIPAL ENDORSING RESOLUTION

WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund (“County Trust Fund”), provides matching grants to municipal governments and to nonprofit organizations for assistance in the development or redevelopment of outdoor municipal recreation facilities; and,

WHEREAS, the Borough of Wood-Ridge desires to further the public interest by obtaining a matching grant of \$300,000.00 from the County Trust Fund to fund the following project: **Wood-Ridge Square Park**; and,

2. That, in the event of a County Trust Fund award that may be less than the grant amount requested above, the Borough of Wood-Ridge has, or will secure, the balance of funding necessary to complete the project, or modify the project as necessary; and
3. That the Borough of Wood-Ridge is committed to providing a dollar for dollar cash match for the project; and,
4. That only those park improvements identified and approved in the project application, its Trust Fund contract, or other documentation will be considered eligible for reimbursement.
5. That the Borough of Wood-Ridge agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and,

WHEREAS, in order to utilize the design-build process under the Act and the Regulations, on March 8, 2023 the Borough adopted Resolution No. 049-2023 which (i) authorized the commencement of such process; (ii) established and adopted procedures consistent with the Regulations for the solicitation and award of the design-build contract for the Project (the “**Design-Build Procedures**”); and (iii) designated a Technical Review Committee to, among other tasks, review and evaluate statements of qualifications and proposals; and

WHEREAS, the Borough desires to make certain minor modifications to the previously adopted Design-Build Procedures as set forth in Attachment A, attached hereto.
