

RE: Self Examination of Budget

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination, and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997, and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 thru 7.5 the Borough of Wood-Ridge has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Borough meets the necessary conditions to participate in the program for the 2014 budget year.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Wood-Ridge that the 2014 annual budget be examined in accordance with N.J.A.C. 5:30-7.6a & b and based upon the Chief Financial Officer's certification. The governing body has found the budget has met the following requirements:

1. That with reference to the following items, if applicable, the amounts have been calculated pursuant to law and appropriated as such in the budget.
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with the "CAP" law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated;
  - b. Items of appropriations are properly set forth
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Director of the Division of Local Government Services.

- ii. Wood-Ridge Development, LLC shall be obligated to be bound by each and every provision of the Redevelopment Agreement made reference to hereinabove. Specifically but not by way of limitation it is understood that the following components be adhere to:
  - a. Subject to the Amendments to the Redevelopment Agreement which tolled certain obligations as noted in this paragraph, notwithstanding anything in the agreement entered into between Fleet Wood-Ridge, LLC and Wood-Ridge Development LLC to the contrary, the parties agree and understand that any and all obligations with respect to public amenities, i.e., construction of school, athletic fields, train station, etc., shall be completed in accordance with the Redevelopment Agreement as amended.
- iii. Fleet Wood-Ridge, LLC will establish and maintain an escrow with the Borough of Wood-Ridge for any and all professional review fees, construction and inspection oversight, etc. requiring as a result of continuing analysis of the subject project and in accordance with the provisions of the Municipal Land Use Law. Such escrow shall be maintained at a \$25,000.00 level at all times in order that the Borough may have sufficient cash on hand to pay any and all relevant expenses as

same are incurred. Fleet Wood-Ridge, LLC shall, within 30 days of the adoption of this resolution, make an initial deposit of \$25,000 into this escrow account.

- iv. This resolution shall be subject to the filing of any and all land use applications with the Wood-Ridge Planning Board in the normal course of said Developer/Qualified Entity seeking such required land use approvals.

**AN ORDINANCE AUTHORIZING THE LEASE OF BOROUGH LANDS TO NEW YORK SMSA LIMITED PARTNERSHIP d/b/a VERIZON WIRELESS IN ACCORDANCE WITH A LEASE DOCUMENT TO BE EXECUTED BY THE PARTIES PURSUANT TO THE TERMS OF N.J.S.A. 40A:12-14 AND N.J.S.A. 40A:12-15.**

**WHEREAS**, the Borough of Wood-Ridge is the Landlord in a Lease Agreement with the New York SMSA Limited Partnership d/b/a Verizon Wireless for premises known as Block 231, Lot 17 a/k/a 261 Union Avenue as same appears on the Tax Map of the Borough of Wood-Ridge (copy of proposed Lease Agreement on file with the Borough Clerk); and

**WHEREAS**, the New York SMSA Limited Partnership d/b/a Verizon Wireless will utilize 64 square feet of space for the installation, operation and maintenance of communications equipment; together with such additional space on an appropriate telephone pole sufficient for the installation, operation and maintenance of antennas; together with such additional space for the installation, operation and maintenance of wire, cable, conduits and pipes running between and among the Ground Space, Pole Space and Antenna Space and to all necessary electrical and telephone utility sources located on the Property; and

**WHEREAS**, the parties wish to enter into a lease agreement and which said agreement is incorporated by reference in this ordinance and same is on file for public inspection in the office of the Wood-Ridge Borough Clerk.

**NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED** by the Mayor and Council of the Borough of Wood-Ridge, County of Bergen, State of New Jersey, as follows:

1. The Mayor, Clerk and/or Borough Attorney are hereby authorized to execute any and all documents necessary to effectuate the aforementioned Lease Agreement with New York SMSA Limited Partnership d/b/a Verizon Wireless. The said lease agreement is incorporated herein by reference and same shall be kept on file and available for inspection during normal business hours in the office of the Wood-Ridge Borough Clerk.

2. The Lease conveyance of land herein authorized is subject to the following terms and conditions:

i. All those provisions set forth in the hereinabove referenced Lease Agreement authorized by this ordinance.

ii. The Lease Agreement as noted hereinabove shall be on file with the Borough Clerk and available for public inspection during normal business hours.

iii. The consideration for the subject Lease shall be the sum of Nine Thousand Six Hundred Dollars (\$9,600.00) per year plus any and all other good and valuable consideration.

iv. The name of the entity which shall be the Lessee will be the New York SMSA Limited Partnership d/b/a Verizon Wireless.

v. The term of the Lease Agreement shall be five (5) years with a commencement date of the first day of the month following the day that Lessee commences installation of the equipment on the premises.

vi. The subject Lease Agreement and this Ordinance shall be deemed to be in accord with N.J.S.A. 40A:12-14 and N.J.S.A. 40A:12-15 and any matters at variance with such Statutes shall be modified so that the within authorization and succeeding documents are in compliance with the dictates of such laws. It is noted that the subject transaction is a non-exclusive grant of the demised premises and that the Borough of Wood-Ridge shall not be prohibited from granting and/or leasing other such parcels to similar entities.

3. All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

4. If any section, subsection, paragraph, sentence, clause or word of this Ordinance shall be adjudged invalid by a Court of competent jurisdiction, then such invalidity shall not affect the validity of the remaining portions of this Ordinance.

5. This Ordinance shall become effective immediately upon adoption and publication according to law.
