Hearing of Citizens:**Old/Business Committee Reports:**

- a. **Dennis Brubaker:** Certifications will be held on March 9th and March 30th. Spoke to Rick Reiter of wrestling who stated that Wood Ridge was being moved into a more difficult division with stronger competition. Dennis suggested that they go back to the league and ask for the reason why this change was made in writing.

- b. **Jerry Lanzerotti:** Track and Field will host an information meeting on March 5th.
- c. **Joe Zielinski:** Monthly meeting will be held on March 15th. Nothing to report.
- d. **Mike McGahn:** Reported on Basketball Meeting which was not well attended. Closing day will be held on March 21st 1-5 p.m. at WRHS. Basketball board reported that they do not see a need for a monthly meeting. Mike suggested a monthly meeting during the actual season. Board also discussed doing away with the South Bergen Basketball registration fee and selecting SBTR members from the recreation participants. They will also do away with referees for divisions 1 & 2. Kids will receive community service for the clock and the score book.
- e. **John Gingerelli:** Parade will be held on Saturday April 4th for both Little League and Girl's Softball. Will speak to Little League as to whether or not they need Finger Printing or Certification.
- f. **Emil Bevacqua:** A change to the bylaws for Soccer was submitted. This change was voted on February 24th at a soccer meeting. Article 23: The Board shall be comprised if no more than 13 voting members. The 13 positions are; President, Vice President, Secretary, Treasurer, Division 1 Coordinator, Division 2 Coordinator, Division 3 Coordinator, Division 4 Coordinator, Field Operations, & up to 4 members at large.
- g. **ToniAnn Azzolini:** Announced that Rich Fallon and Maureen Cavouto will be chairing the Spring Egg Hunt. They will be adding a bake sale as well as a 50/50 which they are licensed to hold. The Spring Egg Hunt will be held on March 28th.
- h. **Ezio Altamura:** Instant verification will be officially hired at the Youth Night Mayor and Council Meeting on March 17th. Jacki should contact Leslie to meet with her and Dennis to discuss plans. Jacki will also remind Elaine to rewrite ordinance. Copy of the ordinance is currently online. Will speak to Paul Barbire about excluding Little League from Finger Printing.
- i. **Recreation Report (Jacki Goldklang):** A final email will be sent to Bill Robol requesting that anything pending from the 2007/2008 season be turned over to recreation. Jacki received a call from Tom Valenzola that WRHS would still be playing JV Girls Softball games at Union Avenue. In order for them to play at WRHS they would need a portable back stop and portable fence. Each would cost \$4,000. WRHS will only be able to purchase one of the two. Inquired whether recreation would be able to purchase the other. Requested to have fees set for each season officially in the minutes for the audit. Fall sports fees for 2009 (Jr. Football/Cheering & Soccer) will be \$50 per child and \$75 for two or more siblings. Assumption School non-residents will be \$75 per child and \$100 for two or more siblings. Summer Recreation will be \$100 for the first child and \$50 for each additional child (2 children will be \$150, 3 children will be \$200, 4 children will be \$250). **Summer Recreation Director Salaries were set. Motion was made by John Gingerelli to set the Director salaries for the 2009 Summer Recreation Program as follows: Davida Gotha and Melissa Manolakakis will receive**

\$360 per week for 5 weeks and 1 additional week for set-up. Ed Rendzio will receive \$360 per week for 5 weeks. Motion was seconded by Joe Zielinski. Vote taken; all ayes. Discussion for changes the hours for Summer Recreation from 9-1 to 8:30-12:30 for children and 8:30-1 for counselors.
