A motion was made by Joe Zielinski and seconded by Jerry Lanzerotti to approve the above bills; vote taken; all ayes, Motion passed.

Hearing of Citizens:

Val Coulter and Vicki Auslander were in attendance to discuss the possibility of a town wide mischief night at the Union Avenue Field. After some discussion, the Recreation Commission suggested that Val and Vicki contact Maywood and discuss what they have done in the past. Vicki and Val were encouraged to come to the September Recreation Commission Meeting to discuss their findings and finalize plans.

Rolando Rojas and Paul Ammerman were in attendance to discuss the Basketball Bylaws. The following revisions were agreed to:

Article 8 – Section 9: Refundable concession stand fee will be eliminated.

Article 8 – Section 11: There will be 1 head coach and 1 assistant coach.

Article 8 – Section 2: Take out blind draft.

Article 8 – Section 5: Take out “coaches to pick South Bergen players”. No cut policy will continue. If there are too many children, a second team will be formed.

Article 24: The approval will be the approval of the remaining board. This should be the same for all board positions.

Page 2 Finances: Should be reported at each regular meeting.

Article 27, Item #3 should include regular open meeting.

Page 3 Article 8: Ages of players should be changed to 2nd through 8th grade (not to include those 8th graders playing of the WR Middle School Team).

Article 29 Section 3: Remove entirely.

No more than 2 coaches on the bench. (ok to leave in)

Meetings will begin in August.

Rolando will make the necessary changes and report back to the Commission for approval.
