Sanitary Inspector: Robert Jernick- This summer most complaints have been regarding high grass. Conditionally Satisfactory Inspection was received by Emilia Romagna over the summer and it has been corrected. At this time Mills Bakery is conditionally Satisfactory and will be re-inspected in 2 weeks. Emilia Romagna's

Violation had to do with hot water at the preparation sink. Mills has a listing of minor violations that adds up to Conditionally Satisfactory.

One summons was issued over the summer for pool water/mosquito larva. The issue was taken care of the next day. Neighbors have been involved with this situation. One of the neighbors on Humboldt reached out to the County and to the Press. The issue had been resolved prior to the Newspaper printing.

Anderson Ave pool complaint was resolved.

Anonymous complaint regarding Columbia Blvd was a complaint about ivy. The properties adjoin each other.

It was noted a deer had been spotted in Wood-Ridge.
