A motion was made by Joe Zielinski and seconded by Emil Bevacqua to approve the above bills; vote taken; all ayes, Motion passed.

Hearing of Citizens:

Tony Seiga was in attendance on behalf of Recreation Soccer to give a brief presentation to request soccer lines on the WRHS Field. The company that he would use paints the lines on the Don Bosco Field. The paint should last approximately 2 years. The cost would be approximately \$995 every two years and the soccer goals would be stored out side of the fence possibly in the area of the score board. Dennis Brubaker stated that the decision of what lines were put on the WRHS Field was never up to the Recreation Commission. The Recreation Commission was only responsible for the scheduling of the field.

Following the discussion, Emil Bevacqua made a motion to recommend that Recreation Soccer go forward with their plans to request temporary soccer lines as stated and proposed by Mr. Tony Seiga. The motion was seconded by Jerry Lanzerotti. Additional discussion followed and a vote was taken; Joe Zielinski – No, Bryon Parisi – No, John Gingerelli – Yes, Toni Ann Azzolini – Yes, Emil Bevacqua – Yes, Dennis Brubaker – Yes. Motion passed.

Old/Business Committee Reports:

- a. **Dennis Brubaker:** Certification is scheduled for July 19th and August 9th at 7 p.m. Talked to Ed Rendzio re: Basketball. He will get together one day after Summer Recreation to hear his ideas.
- b. **Jerry Lanzerotti:** Soccer is coming along. Meeting was held. Drafts are currently in progress. Field set-up will be 8/28 and 8/29. Picture Day is 9/25.
- c. **Joe Zielinski:** Comp Cheer will stay under Jr. Football. Conflict with Flag and CCD will be resolved.
- d. **John Gingerelli:** Little League is finished.
- e. **Bryon Parisi:** Nothing new with Basketball.
- f. **Emil Bevacqua:** U.S. Sports camp went very well. Next year we will accept registrations at the Civic Center and forward to U.S. Sports weekly.
- g. **Toni Ann Azzolini:** PTA would like to hold the Ragamuffin Parade on Sunday October 31st – Halloween. Everyone is ok with that.
- h. **Ezio Altamura:** Report given by Ed Marino. Would like recreation to conduct a t-shirt design contest for the upcoming Mayor's 5 K. Ed will forward details to Jacki. No update with the status of Pomponio Field. Blvd Park is in the process of reissuing the bids.
- i. **Recreation Report (Jacki Goldklang):** Sr. Babe Ruth would like to buy t-shirts for League Champions. John Gingerelli made a motion to cover the cost of the shirts if additional funds are needed, seconded by Toni Ann Azzolini. Vote taken; all ayes. Questioned whether anyone had anything to report on Summer Basketball. Nothing heard from Kevin Plosia.

New Business:

A motion was made by Toni Ann Azzolini, seconded by Emil Bevacqua to give Ed Rendzio 1 personal day per week with pay for the remaining weeks of recreation if needed. If additional days are needed they will be allowed without pay. Vote taken; all ayes. Motion passed.
