Hearing of Citizens:

Kevin Rooney (TGA) Franchise – Jr. Golf enrichment program held September through June and Summer Camps held during June – August. Program uses soft golf balls and teaches all golf swings. They always use mats regardless of the surface. They supply clubs. Students get a work book, drills, (5 levels), and an 8-1 ratio of children to instructor. Other towns that they are currently in are Rochelle Park, Fairlawn, Park Ridge, Tenaflly, Westwood, Queen of Peace, and Saint. Mary's. Emil will check it out and report back.

Mike Carcich – WRHS Baseball Coach was in attendance to finalize his spring baseball camp to be held at WRHS 4/20-4/22, 9-1.

Mike Oppido – WRHS Carnival Planning for April 29th, 30th and May1st. Would like to use Union Avenue Field. Rides need to be set up 3 days in advance of event for insurance purposes. The money raised would benefit all of the classes in the high school to reduce senior debt. They would be using 21st Century Rides that has a 3 million dollar liability insurance certificate. Games, Food, Rides etc. would be available. Recreation Commission suggested speaking to Fun Time Entertainment and local vendors for food. Elizabeth an amateur Qui Gong instructor would like to give a free class to adults in Wood Ridge. Recreation Commission unanimously voted no to the free class. The money to reimburse the groups for the deduction in registration fee for finger printing was not done. Distributed Wood Ridge Memorial Foundation Ad Journal and Dinner forms.
