- c. **John Gingerelli:** Little League and Babe Ruth are both doing well. Meeting was held will Jr. Football. WRHS Football Coach was in attendance.
- d. **Toni Ann Azzolini:** Nothing to report.

- i. **Recreation Report (Jacki Goldklang):** Information and copies of a proposed brochure for a Track & Field Camp to be held at the WRHS Field and run by WRHS Coach Adam Tinter were distributed. After some discussion it was agreed that the camp could be held. A suggestion to release all boys and girls by the refreshment stand was made. He would like to run his camp from July 30th through August 2nd (9 to 1 p.m.). ***Jerry Lanzerotti made a motion to allow the Track & Field Camp to be held on the WRHS Field. The motion was seconded by Toni Ann Azzolini. A vote was taken, all ayes. Motion passed.***
Request from a CE Doyle School teacher to register her children that attend the WR Schools but reside in Clifton NJ was received. A non-resident fee is already in place for all sports. (\$75 per child or \$100 per family for two or more siblings). After some discussion, a motion was made by Jerry Lanzerotti as follows: ***Teachers that teach in the Wood Ridge Schools and all other non-resident WR Public School Staff Members, that choose to have their children attend the WR Public Schools as part of their contract would be allowed to participate in the Wood Ridge Summer Recreation Program. The fee for participation would be \$200 per child and \$100 for each additional sibling. The motion was seconded by Tony Sartori. A vote was taken, all ayes. Motion passed.***
