WHEREAS said list and certification specify the exact line item in the Budget or Ordinance to be charged therewith;

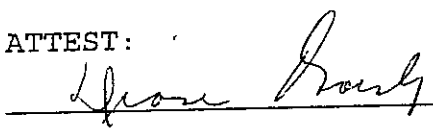
