He also told Jacki to bring the Girl's Softball flyers to the Robert L. Craig School for distribution.

Unfinished Business/Committee Reports:

- a. **Dennis Brubaker:** Reported on the recent coaches certification and spoke about the confusion with the WR PTA. Modifications will be made to eliminate the problem in the future. The WR PTA will either schedule their time before or after Recreation, not at the same time.
- b. **Jerry Lanzerotti:** Nothing to report.
- c. **John Gingerelli:** Girl's Softball will begin meetings in January. Registrations have begun and are coming in slowly. Jr. Football/Cheering is having some problems with the collection of uniforms.
- d. **Toni Ann Azzonlini:** Cinelli Iron & Metal is the winner of the 2013 Adult Softball League.
- e. **Bryon Parisi:** Jr. Wrestling will hold a scrimmage at WRHS on 12/13/13.
- f. **Barbara Fischkelta:** Reported on the concerns of Bill Hammer (padding on stage and door to the Assumption School Gym as well as the lack of a cage on the scoreboard). Basketball Pics will be held this weekend.

- g. **Tony Sartori:** Nothing to report.
- h. **Ezio Altamura:** Announced that Phil Facendola will be our contact for Moonachie Recreation. Reported on the AED's. In order to be certified, you need a 2-4 hour course every 2 years. We can use our own Fire Department for the training. All Athletic Fields must have them. We will have a presentation at the January meeting to discuss in further detail. Paul Sarlo received a 4.8 million dollar grant to be used for repairs at WRHS. Repairs may include air conditioning, boilers & windows. Lightening detectors have been ordered.
- i. **Recreation Report (Jacki Goldklang):** Jr. Football paid \$1,170 to the borough to cover additional 2013 expenses. Indoor Soccer registration will be open until 12/12/13 (currently at 50 registrations, 2013 had 32). Wrestling has 54 registered (45 in 2012/2013). Marc Peck former recreation wrestler is volunteering and doing a great job coaching. Basketball registration is at 249 (229 in 2012/2013). Justin Tuck Football Camp is interested in possibly using the Wood Ridge High School Facility for its spring training camp for youth. Soccer vouchers were received from Gerry Cala, treasurer. Jerry Gonzalez once again did not submit his vouchers. Jacki will send Jerry a Thank You for his donation to Fall Soccer. Coaches Certification has been scheduled for 2014 (3/10, 6/9, 8/11, & 12/8). YMCA will once again use the Civic Center as a drop off/pick up site for its camp in August (8/26-8/30) between the hours of 7:30 a.m. and 5 p.m. Bittersweet will use the Civic Center on 12/21 for their Gingerbread making family event. 2013 Budget breakdown was submitted and distributed.
