- j. **Recreation Report (Jacki Goldklang):** Reported that Instant Verification would like to raise the background check rate for coaches from \$35 to \$38 for rechecks and the rate of first time back ground checks from \$10 to \$12 (this is their first increase since working with our program). Reported Summer Recreation has 3 sites, 61 staff (41 paid and 17 volunteers). WRIS – Grades 1-3 has 130 children, WRJSHS – Grades 4-6 has 156 children and Doyle – Grades 7 & 8 has 116 children (total 402), Fall Sports as of this meeting Soccer has 280, Cheering has 79, Football has 78.
