- j. House of Thaller recalling 10 packages of Hummus with pine nut topping due to possible listeria contamination; Hampton Farm is recalling Ava's Brand Organic Roasted Unsalted Cashews and Almonds due to possible listeria.

Bush Brothers is recalling Brown Sugar Hickory Baked Beans and Original Baked Beans due to a defect in the seams which may cause harmful bacteria to grow inside can; Apace Packing is recalling Cyclobenzaprine HCl 5 mg tablet due to potential mislabeling; ICU Medical is recalling 0.9% Sodium Chloride Injection due to piece of steel within a single container.
