Police-The Wood-Ridge Police continue to be a constant presence at all fall sporting events sponsored by the Wood-Ridge Recreation Program and the Wood-Ridge High School. Active shooter training has been ongoing and in collaboration with the Hasbrouck Heights Police Department. All officers are required to experience 8 hours of training as per the New Jersey Attorney General directive. Training sites have been the Baptist church on Passaic Street and the Hasbrouck Heights High School to promote familiarity when responding for mutual aid. Chief Michael O'Donnell completed the Certified Public Manager Program conducted by Rutgers University in Newark, NJ. This year long educational course is geared toward fine tuning the Chief's organizational goals through effective planning, prioritizing and empowering others by delegating clear job

expectations while creating a motivational environment. The L.E.A.D. program is underway at the Wood-Ridge Intermediate school. Officers are visiting the classrooms of the 4th, 5th and 6th grades to teach the students about character building and why it is important to have high self-esteem. The officers talk about risky behavior and the consequences of their actions. The program is always well received by the students, parents and school staff. The Wood-Ridge Police completed their biannual firearms qualifications throughout the month of October. All officers have proficiently qualified with their weapons. CPR training was conducted by Sgt. Robert Jones. All officers are trained in CPR and the use of the AED. The Wood-Ridge PBA participated in the Trunk or Treat event on October 30 at the Catherine E. Doyle School. The event is sponsored by the Wood-Ridge PTA and PBA. Detective David Marchitelli and Ptl. Rob Cangialosi visited the Doyle School to speak to the students about Halloween safety. They also visited the students of the Intermediate school to speak about cyber safety, harassment and bullying.

Recreation-These are the Recreation Commission Meeting minutes for the Recreation Commission Meeting of October 12, 2022. The YMCA contacted Jacki in reference to a new program for 7th graders called the 7th grade initiative in which 7th graders are given free YMCA Memberships and invited to many different types of events to encourage participation in sports and healthy activities. The Borough of Moonachie 2022 Budget paperwork was completed with the invoice sent to Moonachie for the \$5,000 fee. Coaches Certification Safety Classes will be held on Tuesdays October 18th, November 22nd and December 6th. Football & Cheering reported that the Juniors look like they will make the playoffs and Peevees have a great shot at making the playoffs too. W-R will host the MFL Superbowl on 11/19. Under Wrestling, Chris Petruno will be stepping down and Bob Cannizarro will be taking over the Jr. Wrestling Program. Meetings are held monthly at borough hall.

FIRST HEARING OF CITIZENS:

Mayor Sarlo declared the Hearing of Citizens to be open.

Patrick Roma of 115 Truman Drive asked for an update of the bike lanes. Administrator Eilert stated bike lanes are governed by guidelines and regulations of the NJ Department of Transportation and the Manual on Uniform Traffic Control Devices (MUTCD). Mr. Eilert continues to review the guidelines, regulations and the manual and has been in discussions on the issue with borough engineer. While from an initial review, it does not appear that the Borough's local streets are eligible for bike lanes, he will contact Mr. Roma with a full report of the findings when a final determination is made.

William Schweizer of 270 North Avenue asked about a new school. Mayor Sarlo stated they are in discussion for 3 potential sites. Each site has positives and negatives to them which they are weighing and discussing. The borough is not taking this lightly and will be putting proposals together and presenting them to the public in January.


